#### A Sad Accident

Jessie Keekmyer, aged two years, living in Wichita county, fell in a tube well Nov. 17<sup>th</sup> and when rescued the little child was found dead. The well was about 120 feet deep and the tube extended down to a depth of 80 feet. The little child slipped down the tube, her mother noticing her just as she fell in but too late to catch her. The Town company, on Monday began moving the engine from the "stone mill" to the springs where they will erect an engine house and put in the pumping works for the water system that will now be rushed to completion.

Mr. and Mrs. Ray, who reside in Nebraska, have been visiting at the home of Peter Draullard, father of Mrs. Ray. Tuesday their little daughter, two and a half years old, died, and was buried to-day in the Gooder cemetery near town.

While Wisdom & Smalley's team was hitched to the front post of the Logan house last Thursday night a crowd of boys, for a little amusement, marched up to the front of the Logan house, when one of the "gang" shot off a gun and at the spur of the moment the team took fright, ran up to the church crossing the ditch and coming down Grand Avenue at the rate of about twenty-five miles an hour, making a break for the barn where they made a dash for the front stable door and going clear through the barn with the two-seated buggy at about two jumps, a distance of eighty feet. Mr. Buel's fine team took a lively spin around the east part of town, on Monday, and finally landed in a heap in the rear of the town company's Board of Trade building on Lake avenue. They were not much hurt nor very badly scared.

Mr. J.E. Irwin, north of town, has a number of good milch cows for sale. Prices, \$25 to \$30.

## Logan County Leader April 19, 1888

Friday noon, as the westbound passenger train was pulling out of Oakley station, the colored porter, Jo. Hoard, discovered a tramp on a car platform and summarily ejected him. No sooner had the tramp struck the ground than he drew a revolver and fired a ball into the back of the porter, who had turned to enter the car. The train was stopped and the tramp captured. Hoard was taken to the hospital at Denver, and physicians pronounced his wound very serious. W. P. H. Scott, as the tramp gave his name, was taken in charge by the Oakley marshal, but about dark he got away and took to the prairie. Sheriff Perryman was sent for and gave him chase. Scott wandered all night, aiming to travel to Oberlin, but got lost and in the morning found himself within a few miles of Oakley, where he was captured. Sheriff Perryman brought his prisoner to Russell Springs, and subsequently returned with him to Oakley. Scott is a boy of about 18 years, and says he lives in Hannibal, Mo., and was going to Denver. He will probably be cured of the trick of carrying a revolver handy to his grip.

J.W. Kerns was summoned to Oakley Monday as witness in the shooting scrape, he having seen some of the fracas from a car window. By the way, the porter who was shot is reported so decidedly convalescent as to be able to resume his run.

Young Scott was given a preliminary examination at Winona Tuesday for the shooting of Hoard, the car porter. He was held for trial in the District Court under bonds of \$500.

Friday morning the St. Elmo hotel at Winona, was totally

destroyed. Loss about \$3000. Charlie Black was called to Winona on account of the fire, to provide a new home for his family who had been boarding at the hotel.

Cheyenne Wells, Colorado, indulged in a hanging bee yesterday morning. A claimholder near Burlington shot two men who persisted in driving across his land and fled to Cheyenne Wells. The citizens conveyed the murderer to a coal shed and hung him.

The new town of Paxton, down on the Hackberry, was platted last week by County Surveyor Meier. Messrs. Bickell & Holmes own the town site, and will improve it at once. Logan county now has eleven towns, not counting Logansport, which is extinguished. There are one or two extra post-offices besides.

The post-office at the Baylor town site is "Edith," instead of Hamrick.

'Gene Hill, who is a skillful taxidermist, has completed the work of stuffing the enormous pelican killed south of town a couple of weeks ago. The bigpouched bird will join the collection in the museum window of Stevenson & Burdick's drug store.

#### A SERIOUS ACCIDENT.

As a platform wagon from this place was crossing the railroad track at Winona last Thursday, the hind seat, containing county treasurer Black and T. B. Thorpe, became detached from its fastenings and the occupants went over backward, striking upon the ground with considerable force. Thorpe was not seriously hurt, but Black received injuries which rendered him unconscious for some time. It is feared that his spine is injured and it will be some time before he is able to attend to business.

#### **BOUNTIFUL RAINS.**

The fine rains which fell throughout this portion of the state last week have done an incalculable amount of benefit to this county and city. The farmers' waning hopes have revived and congratulations on the crop outlook are the order of the day. There is no disguising the fact that the dryness was beginning to cause a slight apprehension on the part of the people of north-west Kansas, but last week's deluge has set those fears at rest and has assured the crops of this region.

The purchase was of 46,030 acres, or 72 sections, making four townships. The Swedes are a thrifty, industrious people and Russell Springs will be their nearest and best market. The tract purchased lies within four miles of Russell Springs.

But after getting there we found that the report was false in every sense of the word. There were about fifteen men at work just putting on the finishing touches. Carpenters are putting on the inside wood work preparatory to the skim coat of plastering and in ten days the house will be completed and if Logan county

cannot boast of a fine court house we do not know where there is a county that can---The work is all done in the very best of workmanship. Elegant offices for all the county officers. Iron door vaults in every office, a fine well ventilated court room, mansard roof with iron railing on deck. Double stairway, high ceilings, large double doors with swing transom over every door, four large windows in every office and in fact no pains has been spared to make the building the finest of the size in the state and at the nominal expense to the county of \$3,000. Anyone who would kick on paying out that for such a building would kick if he had to buy a coffin for his grandmother.--Winona Messenger
