The Sunday School picnic which was given at the grove five miles west of town last Friday was a very pleasant affair. Quite a large crowd gathered, composed mostly of Sunday School scholars and teachers.

Logan County Republican September 6, 1888

Faulkner & Ford have sold their stock of groceries to S. Smith, by whom the business will be continued at the same place. Mr. Smith will be assisted by J. B. Travis, who has a large experience in this line of business.

Commissioners Sims and Dermot went down to Topeka Tuesday to get estimates for cells and the cost of putting them into a jail, so that some idea might be obtained as to the probable cost of furnishing this county with a jail. The proposition to vote bonds for the construction of a jail building and purchase of cells or steel cages will probably be left to a vote at the general election. ---Winona Clipper.

They examined jail plans and got estimates as to the probable cost. Such cells as this county will probably need will cost \$3,000, and it is estimated that the building surrounding the cells, including a sheriff's residence, will cost about \$2,000.

Sheriff Perryman spent a day this week looking after the condition of the Logan county contingent in the Ellis county jail. He found them less miserable than reported but by no means as comfortably situated as some of them deserve. An effort will be made to secure the pardon of Evans, who was sentenced for six months on account of an affray, and who is reported by his physician as likely to die if kept in confinement. Russ will be released on bail, and the only Logan county prisoners who will remain in jail will probably be the alleged horse-thief and Tipton, who will both be tried at the November term of court. Judge Osborn and the county commissioners have been notified of the condition of affairs at the Hays City jail and prompt action will be taken.

MISHAP OR MURDER? VERY PROBABLY THE LATTER! Albert Neubauer, a Homesteader in Logan County, Slain. And a Neighbor Strongly Suspected

And a Neighbor Strongly Suspected of His Murder!

Last Monday morning about 10:30 o'clock, John Carson, a young man living in the southern part of the county, had occasion to call at the claim shanty of Albert Neubauer, a settler well-known here. On entering

the house Neubauer was discovered lying on his bed, and the fact was quickly disclosed that he was dead. After notifying some of the neighbors, Carson came to town and gave information to the authorities. Coroner Royce, Sheriff Perryman and Constable Cannon proceeded to the claim of Neubauer, about a mile and a half south-east of Paxton, on Tuesday morning, and the coroner summoned a jury for inquest. Their verdict was to the effect that deceased came to his death by reason of a gun-shot wound.

Neubauer, who was a man about forty years of age, was found dead in his bed, with a gun-shot wound in his left chest, at the time above stated. Fifty-two No. 6 shot were lodged in his body, the shot ranging downward and penetrating his lungs. The nature of the wound, coupled with other circumstances, lead to the belief that he was shot while coming up a bank about eight rods from the house, as blood was found there and at other places nearer the house. On the back of his head was an inconsiderable scalp wound, such as might have been occasioned by a fall. The gun of the murdered man stood in a corner of the room, unloaded, and bearing no evidence of a recent discharge. When found the body was still warm and the limbs were not stiffened. In the stable stood his team with the harness on, indicating that the owner had prepared to drive

Mr. Neubauer was a hardworking settler, of quick, irascible temperament. He had been at outs with his neighbor. Ira Stevenson, who lived about a quarter of a mile from him, mostly on account of trivial matters, such as occasionally cause ill-felling in small communities. Mr. Stevenson, who is well-known to many of our citizens, among them J. E. Cummins and H. L. Allen, is said by them to be a quiet, peaceable man, and they are loath to believe him guilty of such a crime as the verdict of the coroner's jury would indicate. On the day of the murder Stevenson drove to Leoti, mortgaged his team and has not since been heard of, a transaction which itself throws suspicion upon him. Sheriff Perryman, who extracted some of the shot from Neubauer's death wound, called at Stevenson's and examined the shot gun he found there, which gave evidence of having been recently discharged. He asked if there were any shot in the house. Mrs. Stevenson at first declared there were none, but on the sheriff beginning to search the house, she produced a pouch containing just such shot as those which had killed Neubauer.

It is upon such evidence as the foregoing that Mr. Stevenson is suspected of having slain his neighbor. It is circumstantial only, and his friends hope he will be able to disprove his connection with the sad affair.

The remains of Mr. Neubauer

were interred in the cemetery west of town Tuesday afternoon

FT. WALLACE RESERVATION.

Commissioner Stockslager, of the General Land Office, has issued instructions to the Register and Receiver of the Wakeeney Land Office to dispose of the Fort Wallace reservation, under the provisions of the bill passed for the survey of the tract.

According to the act, 640 acres are to be reserved to the town site of Wallace. The price of the land open for settlement is \$2.50 per acre, the tract being double minimum land. Other reserves have been made for waterworks, etc., and the balance will be thrown open to settlement in 40 acre tracts under the homestead laws. The right to commute to cash will not obtain and the full five years of residence will be required.
